










New excavations [km]






## **Key drivers**

- (-) Weaker demand for electricity caused by the slowdown in economic processes due to the coronavirus pandemic
- (+) High yield in Q4 2020 positively affected the 2020 yield and, despite technical and geological problems, the yield in 2020 was 64.0%, which was similar to 2019.

- (+) Lower production costs: the decrease in mining output translated into a lower cost of consumption of materials and third-party services





CO<sub>2</sub> prices remain high


## CO<sub>2</sub> (Dec-20) emission allowances






#### Prices of "green" property rights (PMOZE\_A)




## **Key drivers**

- (-) Lower generation from conventional sources due to the lower availability of units (scheduled modernizations), higher electricity imports and weaker demand due to the coronavirus epidemic






## Volume of distribution services








### Capital expenditures [PLN million]





## Execution structure 2020













# **Customer Social Responsibility**

More than PLN 5.3 million – this is how much we donated in 2020 for combating the coronavirus pandemic

- Since March 2020, financial and material donations have been received by 51 hospitals and treatment centers across Poland. In November and December alone, that was nearly PLN 850 thousand for 13 centers
- This aid gifted through the ENEA Foundation and LW Bogdanka is used, among others, to purchase medical equipment and necessary sanitary and personal protection products
- This support is provided to medical centers operating in the territory where the Enea Group operates. They included, among others, medical centers in Białystok, Busko-Zdrój, Chodzież, Poznań, Radom, Szczecin or Zwoleń
- The list of medical institutions receiving the support is developed in cooperation with the Minister of Health and the Ministry of State Assets

#### Mission: Prevention. Health begins in your head

- It is a preventive health care project for Enea Group employees, which was launched in 2018 and run +
- by the Enea Foundation

  Last year in November, employees attended a meeting with specialists in the field of neuroscience and the special state of the speci pandemic
- As part of the Mission: Prevention campaign, a series devoted to healthy spine and correct posture during remote working was also carried out



# **Customer Social Responsibility**



Enea Group is developing social projects and actively supports the fight with the pandemic

More than 75 liters of blood were collected in 2020 as part of the "Energy in Our Blood" program

- This project is carried out in cooperation with the Regional Blood Donation and Hemotherapy Centers. Since the beginning of the campaign, nearly 275 liters of blood was collected in the Enea Group
- What is important, in addition to the Group's employees, their families and people from outside the Group, such as uniformed services, have become involved in the blood collection drives
- This year the activity was extended to include information campaigns were conducted to encourage employees to turn up for vaccinations against COVID-19 and to donate plasma by individuals who had been infected with the SARS-CoV-2 virus


